- Employee training/hours on ethics/safety
- Community investment per dollar of revenue

### Step 3: Scale Your CSR Metrics

A CSR scale adds rigor by scoring and comparing results in a standardized way. There are three common approaches:

1. **Indexes:** Market-weighted scores like [FTSE4Good](#)
2. **Rankings:** Performance tiers like [Top 100 Global Sustainability](#)
3. **Ratings:** Company-by-company evaluation bands
